RULE 19(EXISTING PROVISION)

The Grand Secretary, who shall be a whole time officer of the Grand Lodge, shall be appointed by the Grand Master from out of a panel of three names submitted to him by the Board of General Purposes. Grand Secretary shall initially be appointed for a period not exceeding five years which thereafter term may extended for a period of not more than two years at a time. The service of the Grand Secretary may be terminated at any time, by the Grand Master, by giving him three months notice in writing, or three months salary in lieu thereof. Similarly, if the Grand Secretary wishes to resign, he shall give three months notice in writing or pay an amount equivalent to three month's salary in lieu thereof. or such shorter notice, or lesser payment, as may be

PROPOSED AMENDMENTS

The Grand Secretary, who shall be a whole time officer of the Grand Lodge, shall be appointed by the Grand Master from out of a panel of three names submitted to him by the Board of General Purposes. Grand Secretary shall initially be appointed for a period not exceeding THREE YEARS STARTING FROM THE DATE OF INSTALLATION OF THE GRAND MASTER AND ENDING ON THE DAY A NEW GRAND MASTER INSTALLED, which term may thereafter be extended for a period of not more than two years at a time. The service of the Grand Secretary may be terminated at any time, by the Grand Master, by giving him three months' notice in writing, or three months' salary in lieu thereof. Similarly, if the Grand Secretary wishes to resign, he shall give three

REASON

The reason is that the Grand Master is free to appoint all fresh officers except the Grand Secretary, whose 5 years term may not have been over on the day of his installation. The incoming Grand Master at his discretion may continue the Grand Secretary for another term, if he so desires.
